# ASCENDI, FULLY OWNED BY ARDIAN, WAS AWARDED THE A69 MOTORWAY CONCESSION BETWEEN TOULOUSE AND CASTRES ALONGSIDE NGE

ASCENDI will implement and operate one of the first free-flow toll systems in France

**Lisbon, October 1<sup>st</sup>, 2021 –** ASCENDI, the second largest motorway operator in Portugal and a key reference in free-flow toll systems, has been awarded the operation of the A69 motorway concession between Toulouse and Castres as part of the consortium led by NGE.

To build this infrastructure, which was declared to be of public interest in July 2018, the consortium will rely on regional companies and create nearly 1,000 local jobs.

The consortium comprised of NGE, Ascendi, and infrastructure funds Quaero and TIIC, will create a dedicated company, ATOSCA, to manage the concession.

The consortium will work closely with government departments, local authorities and elected officials. It will continue consultations with all stakeholders to ensure the success of the project, with the aim of starting work by the end of 2022 and beginning operations in 2025.

Luis Silva Santos, CEO of ASCENDI, said: "This project enshrines ASCENDI's expertise in the design and operation of innovative toll solutions, which is at the heart of our international development strategy."
